Training Requirements

New School Board Members (70 O. S. 5-110)

School Board Members must complete 12 hours of instruction as listed below. For new or appointed School Board Members these hours must be completed within 15 months preceding or following election. School Board Members may attend Workshops conducted by the State Department of Education, State Board of Education approved workshops/seminars, and Higher education institution workshops/seminars/classes to obtain the required number of hours. (Current 2013)

Incumbent (Reelected) Member (70 O. S. 5-110)

Incumbent School Board Members are required to complete 6 hours emphasizing changes in school finance, Oklahoma education laws and ethics, duties and responsibilities of district board of education members, within 15 months following reelection plus the Continuing Education hours listed below. Continuing Education hours must be completed prior to filing for reelection.

School Board Members may attend Workshops conducted by the State Department of Education, State Board of Education approved workshops/seminars, and Higher education institution workshops/seminars/classes to obtain the required number of hours.
