GV-VEHICLE LEASE POLICY

Vehicle Lease Agreement

Gore Public Schools (Lessor), an Oklahoma school, with an address of 1200 North Highway 10 Blvd, Gore, OK. 74435, agrees to lease to _____, the following vehicle:

This lease will be executed on the following dates: _____

Upon completion of the lease, lessee will return the vehicle at the aforementioned address in the same condition and appearance as received.

Lessee agrees to the following conditions for leasing:

- to provide insurance equal to the value/replacement cost of the vehicle and to provide liability insurance equal to the amount carried by Gore Public Schools. Without limitation, Lessee shall furnish Lessor with a copy of an insurance certificate/policy reflecting the liability limits equal to or greater than amounts hereinafter required
- to use a certified bus driver/appropriate license holder that is employed by Gore Schools or substitutes for the Transportation Department of Gore Public Schools and pay all associated costs for that driver
- to reimburse Gore Schools any fuel and related costs associated with the usage
- Lessee agrees that the Bus will not be operated (A) to carry passengers for any other reason than listed above, whether express or implied; (B) in any race, test, or contest; (C) by any driver in possession of or under the influence of alcohol or any drug that may impair the ability to operate the Vehicle; (D) in a reckless or abusive manner; or (E) while improperly loaded or loaded beyond the maximum passenger limits. Lessee agrees to reimburse Lessor in full for damages, including expenses, resulting from any violation of this provision.
- Lessee agrees that no tobacco of any kind is used while on the bus.
- Lessee promises to operate the bus only in the normal and ordinary course of Lessee's business, and not in violation of any law, rule, regulation, statute, or ordinance. Lessee shall indemnify, defend, and hold Lessor harmless from and against all fines, forfeitures, seizures, confiscations, and penalties arising out of any violation.
- Lessee shall notify Lessor immediately of any accident or collision arising from the use of or otherwise involving any portion of the bus. Lessee shall make a detailed report to Lessor concerning such collision in writing as soon as practicable, by the most expedient means of communication available. Lessee further agrees to render any other assistance to Lessor and any insurer in the investigation, defense, or prosecution of any claims or suits.
- Lessee may not assign this agreement or any of Lessee's rights under this agreement without the prior written consent of Lessor. Lessee may not sublease the bus, or permit others to use the bus, without the prior written consent of Lessor.
- Modifications or amendments to this agreement are valid only when made in a writing that is signed by all contracting parties. Oral agreements purporting to modify or amend this agreement are void and of no effect.
- Additional fees will be applied to all non GPS School related trips that exceed 400 miles, round trip, and will be assessed at a rate of \$0.55 per mile for every mile in excess of 400.
