- provide a written explanation, including a statement regarding the right to appeal under subparagraph (E), to the homeless child's or youth's parent or guardian, if the local educational agency sends such child or youth to a school other than the school of origin or a school requested by the parent or guardian; and
- in the case of an unaccompanied youth, ensure that the homeless liaison designated under paragraph (1)(J)(ii)
 assists in placement or enrollment decisions under this subparagraph, considers the views of such unaccompanied
 youth, and provides notice to such youth of the right to appeal under subparagraph (E).
